<u>Article 1:</u> The provision of ½ set of golf equipment is open to all members of the BDGC Academy. The equipment concerned by this provision is the following: bag, wood, irons and putter of the MKids, Skymax or Cleveland brand.

Article 2: The reservation of the equipment will be made by means of the form of provision of the equipment which will be returned to the person in charge Basile Lengrand, by email: shop@bdgc.be

<u>Article 3:</u> The equipment will only be made available against payment of the membership fee which will be sent to you by email:

- For an annual loan amount of 100€.
- By paying a deposit of 180€.

These payments must be made to the order of DGDS, one for the deposit and the other for the provision of equipment.

No equipment will be made available without these payments and the duly completed form.

**Article 4:** The equipment will be returned at the end of the year, at the latest during the last course if the membership to the BDGC Academy is not renewed.

<u>Article 5:</u> The equipment made available is in working order. It will be checked before each use and when it is returned. The signature of the member will be obligatory on the "equipment availability" form and will commit his agreement and his responsibility on the following points:

- ➤ In the event of loss or theft of the borrowed equipment, the "borrowing member" accepts the cashing of part or all of the deposit for the replacement of the lost or stolen equipment.
- ➤ In the event of damage to the equipment, the "borrowing member" undertakes to pay the bill for repairing the equipment, failing which the deposit will be cashed for the amount of the said repair. Repairs due to wear and tear occurring during normal use in accordance with the rules of golf shall be paid for by the BDGC.
